

# STUDENT WITHDRAWAL PROCEDURES AND REFUND POLICY FOR VSL APPROVED COURSES

### Definitions

### Organisation:

Demi International Beauty Academy Pty Ltd trades as Demi International Beauty Academy.

*Student:* refers to an eligible student who uses a VET student loan to pay all or part of their tuition fees.

*Course:* refers to an VSL Approved Course that has been approved for eligible Students to use a VET student loan to pay for all or part of their tuition fees.

Tuition Fees: refers to fees paid for a Course.

*Census Day:* refers to a published date set by an approved course provider for each fee period that is at least 20% of the way through the fee period.

## 1. Withdrawal from a Course

A withdrawal of a Student's enrolment in a part of a Course before the Census Day for that part of the Course must be in accordance with this policy.

A Student of Demi International Beauty Academy who wishes to withdraw from a Course must do so by completing a *Withdrawal Form* available on our website: <u>www.demiinternational.edu.au</u> and sending it to Demi International Beauty Academy, 9/31-33 Plaza Parade, Maroochydore Qld 4558 or by email to: <u>admin@demiinternational.edu.au</u>.

Demi International Beauty Academy will not charge any VSL fees for a Student to withdraw or impose any barriers on a Student that seeks to withdraw from a Course or part of a Course.

Where a Student has earlier withdrawn from a part of a Course they may apply to re-enrol in a part of the Course by contacting <u>admin@demiinternational.edu.au</u>.

Where a Student withdraws from a Course, or a part of a Course Demi International Beauty Academy will not, after the withdrawal, enrol the Student in a Course or a part of a Course without the written permission of the Student (which must be given after the withdrawal).

#### 2. Refunds

In the event of a Student withdrawing from part of a Course **before** the Census Day for that part of the Course, the Student will not incur a VET student loan debt for that part of the Course and will receive a refund for any up-front payment of Tuition Fees for that part of the Course.

In the event of a Student withdrawing from a part of the Course **on or after** the Census Day for that part of the Course no refund is applicable, and the Student will incur a VET student loan debt for that part of the Course. A \$500 early exit fee will be charged.

### 3. Payment of Refunds

Refunds will be paid within 30 days of the Census Day of that part of the Course to which the withdrawal applies.

### 5. Publication
